The Department recommends revisiting the 'Mass License Renewals' service on a regular basis throughout the renewal period to ensure you have completed all of your renewals. The renewal period ends June 30, 2024 at 4:30 PM CDT

I certify that the information submitted in and with this application is true and complete, and that I have read and understand the requirements under Minnesota Statutes Chapter 332. I acknowledge that a copy of the Minnesota Statutes can be obtained free of charge at www.revisor.mn.gov.

I further certify that I will comply with these standards and provisions during the period of my licensure, including but not limited to sending written notice to the commissioner of any change of information contained in the license application within 10 days of the change. I understand the types of misconduct for which disciplinary proceedings may be started against a licensed individual or a licensed company.
